9. Description: This five bay by one bay, two and a half story rectangular log and frame house faces west. Built in two sections, the south three bays are log and the north two bays are frame. There is no west (front) porch, but there is a porch on the east elevation with a shed roof supported by three square wooden posts. There are two over two double hung windows throughout. The gable roof has red raised seam metal covering.

10. Significance: The Horine Log House site is associated with Stephen Newton Chiswell (1715-1805), one of the earliest settlers of this area; the southern, oldest part of the house is of log construction and may go back before 1800. According to legend, Chiswell, who emigrated to Maryland in 1735, eloped soon afterward with his cousin Sarah, and fled to the wilderness where they built a log cabin. Possibly they rented land at first or occupied it without formal papers. In 1761, Chiswell began obtaining large tracts of land between Boyds and Poolesville. The 1783 Tax Assessment shows a small log house on a 150 acre parcel called "Henry", this may have been the original of the Horine House. In 1792, Chiswell repatented his parcels as "Stephen Newton Chiswell's Lodge". An old log house on the adjoining L. M. Lewis property, torn down in the early 1900's, may have been either the original Chiswell log house or that of one of his children or tenants. About 1821 the Bethel Chapel was erected on "Chiswell's Lodge", serving Baptists in the area and having an adjacent family cemetery. The land was sold to Samuel and John W. Darby in 1856. It has been in the Horine family since 1907.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This five bay by one bay, two and a half story rectangular log and frame house faces west.

Built on fieldstone foundations, the south three bay, two and a half story section is log while the north two bay, two and a half story section is frame. The entire house is now sheathed by unpainted clapboards. There is no west (front) porch although there is a wooden paneled door at the south end of that elevation with a stone step before the door. On the east elevation there is a shed roof supported by three square wooden posts. The east door is wooden paneled.

The windows are mixed, some two over two double hung, others nine over nine. There are two small four light windows in the south gable and one four light window in the north gable.

The house has a gable roof with red raised seam metal covering. There is one interior stove chimney.

There are no windows on the south wall of the first and second floors -- only windows at the attic level. There is a single window at the middle of the north wall, first and second floors. The foundation stones in the north section are red Seneca sandstone. The house has a single chimney.

Considerable water damage is apparent, and the foundation has begun to give way, due to neglect.

STATEMENT OF SIGNIFICANCE

The date of the original part of the Horine farm house has thus far (1979) not been determined. The oldest part of the house, the southern end, is of log construction and may go back to before 1800. Careful architectural examination may yield some clues.

The site is associated with Stephen Newton Chiswell (1715-1805), one of the earliest settlers of this area. According to legend,¹ Chiswell, who emigrated to Maryland in 1735, eloped soon afterward with his cousin Sarah and fled to the wilderness of what was later to become upper Montgomery County. There they built a log cabin in which they lived happily for many years. Quite possibly they rented land at first or occupied it without formal papers.

The first tract of land taken out in Chiswell's name was "Sarah's Choice", 67 acres which he patented in 1761.² Later he obtained several other large tracts in the area between Boyds and Poolesville. Tax records show a 46-acre "Addition to Sarah's Choice" in 1783,³ but list no improvements on either tract. Another parcel called "Henry" of 150 acres is listed as having a small log house;⁴ this may have been the original of the Horine house, but it is impossible to say for sure.

In 1792 Chiswell resurveyed "Sarah's Choice" and adjoining parcels and repatented them as "Stephen Newton Chiswell's Lodge".⁵ This tract can be definitely identified with the area which includes the Horine lot, but again the house itself eludes identification. An old log house on the adjoining L. M. Lewis property immediately to the south, torn down early in the present century, may equally have been either the original Chiswell log house or the house of one of his children or tenants.

About 1821 the Bethel Chapel was erected on "Chiswell's Lodge"; it served Baptists in the area, including the Chiswells. The Chiswell family cemetery was also in use by this time.

After the era of the Chiswells the land passed first to Samuel Darby and John W. Darby,⁶ then to Lewis D. Mainhart,⁷ and in 1907 to Edwin M. Horine.⁸ It has remained in that family since.⁹

The sheathing is weatherboarding.

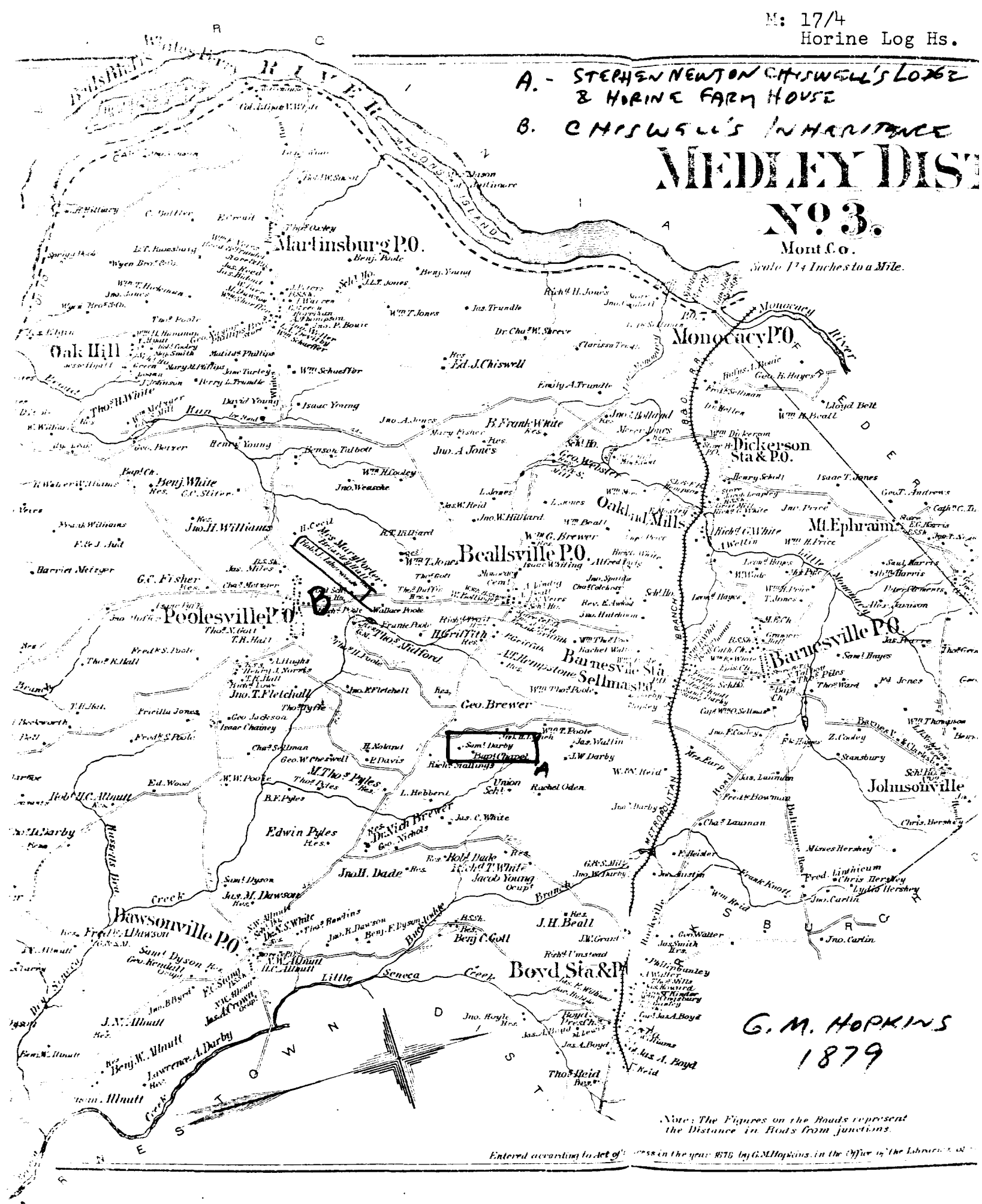

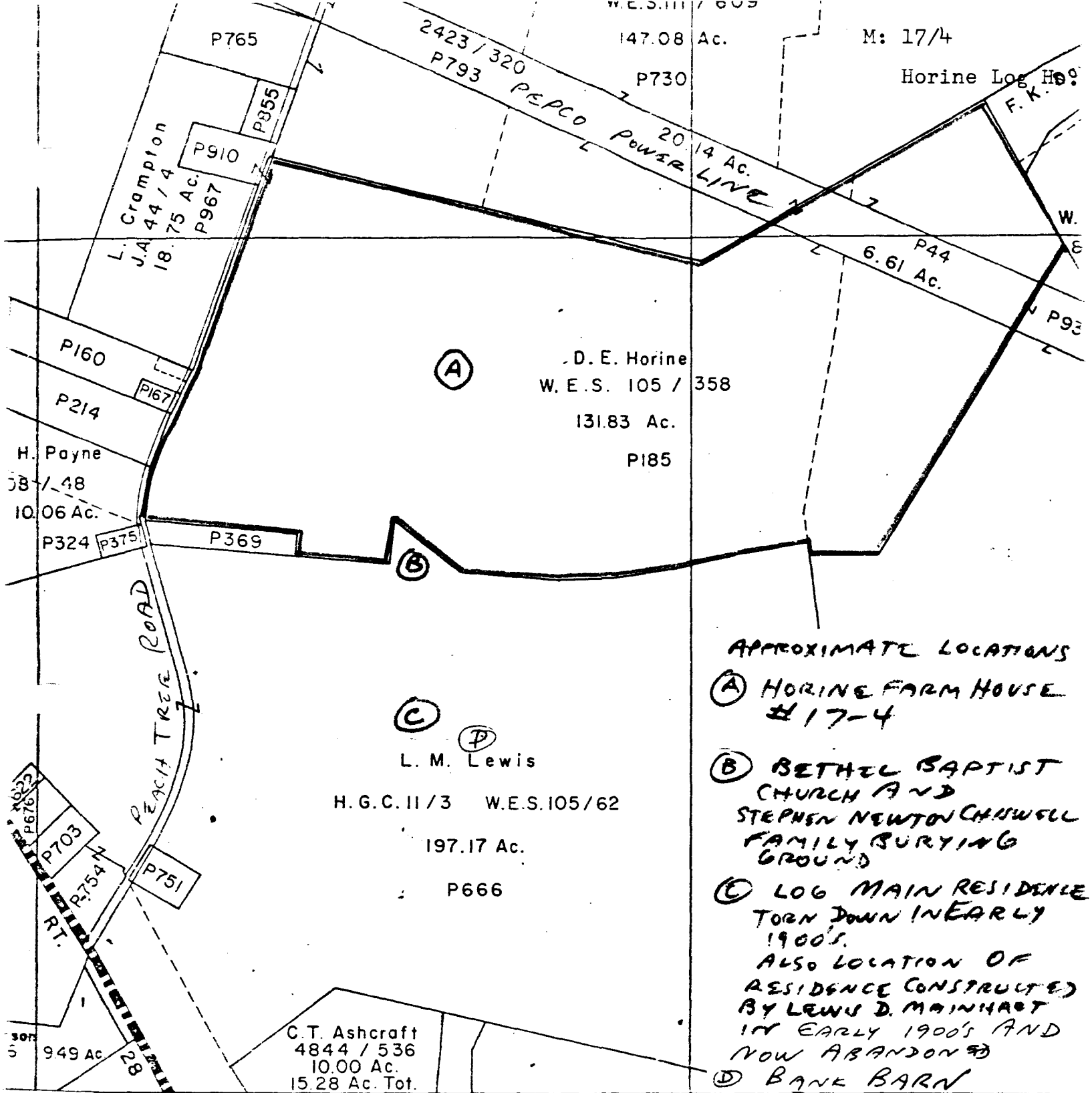

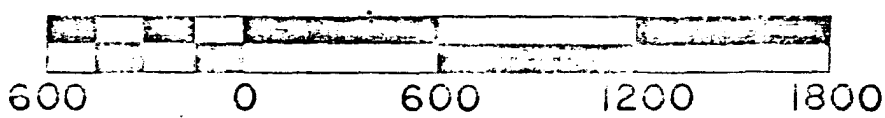
